

# **Privacy Policy Statement**

The Federal Ministry for the Environment, Nature Conservation, Nuclear Safety and Consumer Protection (BMUV) takes the protection of personal data very seriously. In our privacy policy, we inform users about which data we collect in relation to events and participant management, how we use that data and what rights they enjoy.

### III: Which information is collected and for what purpose?

Users can register for specific events via our website. To this end, personal data is needed (title, name, address, organisation/company, position, phone number, e-mail address).

The information in the required fields is necessary to address users correctly with their first and last name. The e-mail address is required to provide participants with the login data for an event and to potentially generate a participant profile on an event platform. Confirmation of acknowledgement of the registration conditions and consent to them are required to demonstrate our compliance with the provision of information obligation and to establish the necessary legal basis. The declaration of being 18 years or older or having the necessary consent from a legal guardian is required to ensure the consent is legally valid. The provision of above data is mandatory for users wishing to register for an event.

Additional voluntary information provided is processed to improve our public relations work and enable us to communicate more effectively with interested groups.

In doing so, users also ensure that they only provide their own data.



Further personal data such as health-related data (e.g. food allergies/intolerances), nationality or ID card/passport information may be requested for certain events due to organisational, contractual and/or legal requirements. Personal data will be used exclusively for the specific event and only processed for the length of time it is needed to carry out the event. Once the event is concluded, personal data is irretrievably deleted after a maximum of 6 weeks. The only exemption are cases where users have explicitly opted to receive invitations and information in future, too, and given separate consent to this effect.

In connection with our press and public relations work, photos and videos will be taken during events and meetings in which individual users may be identifiable. The users concerned may object to such photos or videos being taken and/or published online and on social media. Please use the BMUV contact details above for such objections.

### IV. How do we protect children and young people (protection of minors)?

Persons under the age of 18 are not allowed to submit personal data to us without the consent of their parents or legal guardian. We do not request personal data from children or young people without the consent of their parents or legal guardian.

### V. What is our basis for collecting personal data?

One of the BMUV's tasks of general public interest is the holding of events on environmental and on consumer rights topics. Personal data submitted by users in the registration form is thus processed in accordance with Article 6 (1) (e) GDPR in conjunction with Article 3 of the Federal Data Protection Act (BDSG).

During BMUV events, photos and videos are taken as part of the press and public relations work of the BMUV. Article 6 (1) (e) GDPR in conjunction with Article 3 BDSG forms the legal basis for processing personal data.

Furthermore, we only collect personal data with the consent of the user (for example to receive information on other BMUV events) or when we are legally obligated to do so (in accordance with Article 6 (1) (c) GDPR). Consent may be withdrawn for the future at any time in accordance with Article 6 (1) (a) GDPR.

### VI. Who do we pass data on to?

We work together with external service providers for the organisation and implementation of events and for participant management. Where personal data is processed, we have put in place organisational and technical measures to ensure that our external service providers also comply with data protection requirements.

Unless otherwise specified, the data will be processed by our main service provider facts and fiction GmbH, based in the Federal Republic of Germany and with which we have concluded a data processing agreement. In individual cases, depending on the event, it may be necessary for our main service provider to assign tasks to sub-contractors with which data processing agreements have been concluded as well. Beyond this, personal data is only forwarded to other recipients when consent is explicitly given by the user or when we are legally obligated to do so pursuant to a legal provision or court decision.



## VII. What are the rights of data subjects?

With regard to the processing of personal data by the BMUV, users enjoy the rights stipulated in Articles 12 to 22 GDPR:

#### • Right of access by the data subject pursuant to Article 15 GDPR

This right grants full access to personal data concerning the data subject and other important criteria such as purposes of processing or storage period. The exemptions specified in Article 34 of the Federal Data Protection Act (BDSG) apply.

#### • Right to rectification pursuant to Article 16 GDPR

This right gives users the possibility to rectify inaccurate personal data concerning them.

#### • Right to erasure ('right to be forgotten') pursuant to Article 17 GDPR

This right gives users the possibility to have data deleted. However, for data to be deleted, it is necessary that the personal data is no longer required, was unlawfully processed or that the consent has been withdrawn. The exemptions specified in Article 35 BDSG apply.

• Right to restriction of processing pursuant to Article 18 GDPR

This right gives users the possibility to provisionally prevent further processing of personal data concerning them. This applies, in particular, in a review phase of the user establishing, exercising or defending other legal claims.

#### • Right to data portability pursuant to Article 20 GDPR

This provision gives users the right to obtain personal data concerning them from the controller in a commonly used, machine-readable format, for example pdf, in order to pass it on to other controllers where necessary.

#### • Right to object pursuant to Article 21 GDPR

This right provides users with the possibility to object, on grounds relating to their particular situation, to the processing of personal data concerning them where this is justified for the purpose of public tasks or lies in the public or private interest. Pursuant to Article 36 BDSG, this provision does not apply where an official authority is legally obligated to process the data.

#### • Right to withdraw consent pursuant to Article 7 (3) GDPR

Users have the right to withdraw their consent for the future at any time. Please use the BMUV contact details above to withdraw consent.

Exercising these rights is free of charge and granted on request in line with the user's information interest. Please contact the Data Protection Officer for the Federal Ministry for the Environment, Nature Conservation, Nuclear Safe-ty and Consumer Protection.



# VIII. Right to lodge complaints with supervisory authority

In cases where the ministry processes personal data, users have the right to lodge a complaint with the supervisory authority for data protection. The competent supervisory authority is:
